We want to tell you about a special designation available to our legacy donors. **The Rob Maxey Legacy Society** (RMLS) exists to recognize and affirm those partners who have pledged legacy gifts to YFC Sacramento in their estate planning. Founded in memory of our beloved transformational leader Rob Maxey, who passed away while serving as Executive Director in 2017, we can think of no better way to honor his memory and his legacy.

Gifts may be directed to the ministry through bequests or deferred gifts, or by naming YFC Sacramento as a primary beneficiary of an IRA, insurance policy, property, or other financial instrument.

By notifying YFC about your gift through a Declaration of Intent (DOI), *regardless of the realized amount of the gift*, you are formally inducted as a member of the RMLS. As a member, you will receive a commemorative medallion in remembrance of Rob's ministry service and impact. Your commitment to make a legacy gift to YFC through your will, trust, or estate plan will ensure that our mission of *giving kids the opportunity to follow Christ, and to become part of the local church*, will thrive for years to come. A DOI is a non-legally binding written document intended to communicate the nature of your legacy gift to YFC. It also ensures that your intentions for your gift are honored.

We are available to help you complete and submit your DOI. We'd also encourage you to include a copy of the pertinent section of your estate documents defining your planned gift for YFC. Along with the DOI, this will help YFC understand and be aware of your intentions.
